B.A. FIRST SEM. ENGLISH LANGUAGE (FOUNDATION COURSE)

Programme Outcome:

- The course will equip the students with the skills necessary to communicate verbally and orally in English.
- The course will teach students the fundamentals of English grammar and how to translate words from Hindi to English and vice versa, allowing them to speak in chaste language.
- In addition to teaching students terminology and presentation techniques, the course will equip them to write summaries, understanding, dialogue, and expansions of ideas.

B.A. SECOND SEMESTER (ENGLISH LANGUAGE) FOUNDATION COURSE

Programme Outcome:

- The course shall enable the students to effectively communicate in both orally and verbally in English.
- The course shall enable the students to use chaste language as they shall learn the basic principles of English grammar.
- The Course shall enable the student to write essay, letter, and application and draft bio-data, report, notice, agenda and minutes.

B.A. FIRST SEMESTER (ENGLISH LITERATURE) PAPER-I: PROSE TILL 18™ CENTURY

Programme Outcome:

- Through a close reading of a few essays written by the period's representative writers, the courses
 give students the opportunity to get familiar with the development and tendencies of English writing
 during the late nineteenth century.
- It will familiarize students with the historical, political, social, and intellectual contexts in order to prepare them to analyze the texts as historical accounts.

Paper-II: Elizabethan Drama

Programme Outcome:

- The courses will familiarize students with the key themes in Elizabethan play by closely examining Macbeth and Twelfth Night by William Shakespeare.
- It will enhance students' comprehension, analysis, and evaluation of both comedy and tragedy.

B.A. Second Semester (English Literature) Paper-I: Poetry till 18th Century

Programme Outcome:

- Through a close study of these selected poems by the period's prominent poets, the courses will help students to become familiar with the development and trends of English poetry until the late nineteenth century.
- In order to enable students to study the poems as representative samples of the era, it will introduce them to the political, economic, social, and intellectual backgrounds.

Paper-II: Eighteenth Century Drama

Programme Outcome:

- The courses will introduce students to the main themes of eighteenth-century English drama through a close reading of Oliver Goldsmith's She Stoops to Conquer and Richard Bransley Sheridan's The Rivals.
- It will help students become more adept in interpreting, analyzing, and assessing plays from the standpoint of literary theory and history.

B.A. Third Semester (English Literature) Paper-I: 19th Century Poetry

Programme Outcome:

- Through a close examination of their representative poems, the courses will acquaint students with the most important English poets of the nineteenth century;
- Equip them with knowledge of the issues facing the Victorian era and their reflections in that era's literature.
- Train them in the close reading of poems in the contexts of literary convention and history.

Paper-II: 19th Century Fiction

Programme Outcome:

- The students will become familiar with the major trends of nineteenth-century English fiction through a close study of Jane Austen's Pride and Prejudice and Thomas Hardy's The Mayor of Cambridge, which are representative of their respective ages and novelists.
- The courses will develop in the students the ability to interpret, analyze, and evaluate works of fiction from the perspective of literary history and theory.

B.A. Fourth Semester (English Literature) Paper-I: 19th and 20th Century English Prose

Programme Outcome:

 The courses will help students become familiar with the growth and trends of English prose in the nineteenth and twentieth centuries through a close study of these select essays of the period's representative prosewriters.

Paper-II: Indian English Fiction

Programme Outcome:

- Through a detailed examination of R.K. Narayan's The Guide and Mulk Raj Anand's Untouchable, which are indicative of their respective ages and the novelist, the courses will acquaint students with the major tendencies in Indian English literature.
- It will help students gain the capacity to comprehend, analyze, and assess fictional works from the standpoint of Indian literary history and theory.

B.A. Fifth Semester (English Literature) Paper-I: 20th Century Poetry

Programme Outcome:

- The courses will acquaint students with the most important English poets of the twentieth century through a close study of their representative poems.
- It will teach students in the attentive reading of poems in the contexts of literary convention and history.

Paper-II: 19th and Early 20th Century Drama

Programme Outcome:

The courses will allow students to closely examine G.B. Shaw's Arms and the Man and J. M. Synge's Riders to the Sea in order to gain an understanding of the development and trends of late 19th- and early 20th-century English drama.

B.A. Sixth Semester (English Literature) Paper-I: American and Indian English Poetry

Programme Outcome:

By closely examining the poems of the country's representative poets, both American and Indian, the course will enable students to comprehend the historical movements and cultural features found in American and Indian English poetry.

Paper-II: Modern English Drama and Fiction

Programme Outcome:

- The courses will acquaint students with the major trends in modern English drama and fiction through a close study of George Orwell's Animal Farm and Harold Pinter's The Caretaker.
- It will develop in the students the ability to understand, analyze, and evaluate works of drama and fiction from the perspective of literary history and theory. your

M.A. (English) First Semester Paper I: Poetry till 1798

Programme Outcome:

- Through a close reading of these selected poems by the period's representative poets, the courses
 will help students to become familiar with the development, growth, and tendencies of English
 poetry up until 1798.
- Students will gain practice reading poems closely within the frameworks of literary tradition and history.

Paper II: English Drama before 20th Century

Programme Outcome:

- Through a close examination of the plays of the period's representative playwrights, the courses will
 enable students to gain familiarity with the development, growth, and major trends of English drama
 before the twentieth century.
- It will enhance students' ability to interpret, analyze, and evaluate plays from the perspective of literary history and theory.

Paper III: English Fiction before 20th Century

Programme Outcome:

- Through a close examination of the representative works of the major novelists of the era, the courses will acquaint students with the development, growth, and major trends of English fiction prior to the twentieth century.
- Students' capacity to comprehend, analyze, and assess fictional works from the standpoint of literary theory and history will grow as a result.


Paper IV: 19 th Century English Poetry

M.A. (English) Second Semester Paper I: Non-Fictional Prose till 19th Century

Programme Outcome:

- The courses will enable students to closely read these select essays written by the period's prominent writers and gain an understanding of the development, progress, and tendencies of non-fictional English prose until the nineteenth century.
- It will familiarize students with the political, economic, social, and intellectual contexts in order to prepare them to study the works as stewards of the past.

Paper II: 20th Century English Drama

Programme Outcome:

- The courses will help students become familiar with the growth and trend of twentieth-century English drama through a close study of the plays of their representative playwright.
- It will introduce students to the political, economic, social, and intellectual backgrounds so they can study the works as representative of the age.

Paper III: 20th Century English Fiction

Programme Outcome:

- With a detailed examination of the books that are representative of the age and the author, the course will acquaint students with the main English authors of the twentieth century.
- It will help students gain the capacity to comprehend, analyze, and assess fictional works from the standpoint of literary theory and history.

Paper IV: 20th Century English Poetry

Programme Outcome:

- By closely examining their representative works, the courses will acquaint students with the most important poets of the twentieth century.
- It will help students get acquainted with the distinctive elements of twentieth-century literature and how those features are reflected in the poetry of the era.
- It will teach students how to closely read poems within the frameworks of literary tradition and historical contexts.

M.A. (English) Third Semester Paper I: Literary Criticism and Theory - till 19th Century

Programme Outcome:

- Through a close reading of these selected texts by the period's representative critics, the courses will enable students to become familiar with the development, growth, and trends of literary criticism and theory from Aristotle to the nineteenth century.
- It will familiarize students with various literary criticism schools and tenets while assisting them in appreciating and assessing literary texts.

Paper II: 20th Century Non-Fictional Prose

Programme Outcome:

Paper III: Indian Literature in English till 1960

Paper IV: Option 2: Pre-independence Indian Literature in Translation Programme Outcome:

- It allows students to examine these texts as a holistic concept of Indianness.
- It allows students to define the concept of "Indian Literature" with the aid of some representative texts from various Indian languages.
